The Brandt Road Culvert Project needs Easement Agreements which will place this project on a later start date than originally planned for. Once Easement Agreements are signed, Township Solicitor Josele Cleary will draft bids for the Brandt Road Culvert Project. DHL's request for a reduction of their 1.6-million-dollar bond for the Killinger Road work to \$245,434.93 is ready for approval.

**Manager's Report**- Township Manager, Jeanette Henning informed the Board of the following: The South Annville Holdings, LLC. (Southgate), Condition Use Hearing decision, which was prepared by Township Solicitor, Josele Cleary is ready for approval. The Lot Addition Plan for Eastern Enterprises, Inc. is ready for approval. This Lot Addition Plan comes with a request for a Planning Waiver & Non-Building Declaration for a portion that is located in SAT. The Wynfield Phase 1B Plans, Vincent Baily Land Development Stormwater Plans and The Eastern Enterprises, Inc. Plans have been reviewed by the SAT Planning Commission and Gordy Sheetz, Chairman for the Commission recommends approving the discussed plans. Spencer Baker, a resident of SAT asked the Board to consider placing a traffic signal at the intersection of Route #422 & Mt. Pleasant Road. The SAT Authority & MFS's EDU Consignment Agreement is ready for approval. Heather Mesko, Assistant Township Manager, presented a thank you from the Annville Free Library for our \$17,000.00 donation. Ms. Mesko **Manager's Report continued-** also told the Board that a link to the library has been added to our website, the MOU with North Annville Township for sharing line striping cost at the intersection of Route #422 & Clear Springs Road is ready for signatures and a thank you were sent out to several families who volunteered their time to pick up garbage along Mt. Pleasant Rd.
