<u>Minutes of May 8, 2024</u>- Motion to approve the minutes of the Board of Supervisors Meeting for May was made by Supervisor Harrell; seconded by Supervisor Rhine. Motion carried unanimously.

<u>Treasurer's Report-</u>Twp. Manger presented the financial reports for acceptance which included the following: Invoices paid and pending, Revenues received, Treasury report fund totals /financial report. Motion to accept the Treasurer's Report was made by Supervisor Rhine; seconded by Supervisor Harrell. Motion carried unanimously.

<u>Citizens/Public Comments</u>- Resident Miller Baird asked the results of the traffic study that was done for Royal Road. The study showed that no change in speed limit was warranted. Mr. Baird asked if a traffic study could be conducted to possibly reduce the speed limit on Bachman Road.

<u>Engineer's Report</u>- Jim Caldwell of Rettew Engineering informed Supervisors of the following activities for the month: Looking into the Wynfield proposed asphalt trail location and permitting process, Candler's Pointe, Southgate Preliminary Plans, Reviewing Carmany Tract. The 2024 Road Line Striping Project and MS-4 Inspections. Mr. Caldwell suggested setting up an onsite meeting with the property owner to discuss an easement for the Brandt Road Culvert Project.

Manager's Report- Township Manager, Jeanette Henning informed the Board of the following: The two one-million-dollar Certificates of Deposit have reached maturity and are ready for possible reinvestments. The Lebanon Western Regional Police Agreement is ready for approval and a Resolution to adopt and authorize the execution of the agreement is also ready. The C.M. High yearly Maintenance Agreement for \$820.00 is ready for approval. The Garcia, Garman & Shay 2024 Audit Agreement for \$6,500.00 is ready for approval. After a presentation by SAT Planning Commission Chairman, Gordy Sheetz, the Garman Wynfield 4-Lot Subdivision Plan was tabled for further discussion. Heather Mesko, Assistant Township Manager informed the Board that two easement agreements for the Brandt Road Culvert Project have been signed. Nora Hoover, a member of the National Honor Society chose beautifying the SAT Office Building for her Community Service Project. A request for a change in signage for the Hinkle and Brandt Road intersection has been received.
